TRADE SITE TERMS & CONDITIONS

****Please read and sign these Terms & Conditions and return them with your application form**** 1. To conform to Occupational Health and Safety regulations, traders are asked to supply their own tagged and tested power cords and electrical equipment. No unauthorised double adapters or power boards are to be used. Failure to comply with this condition will result in disconnection. Please note we can only provide you with the power outlets and amps you have requested in your application.

2. Power outlets must be booked with your trade site and paid for with your application. No extra/other equipment will be available on show day.

3. Applicants must state the full size of their trade stand on the application form (including vehicles, trestles, tables and overhanging awnings).

4. Stall holders **must have their own current Public Liability Insurance** and submit a copy with their Trade Site Application. Applications without proof of insurance will not be accepted.

5. The Naracoorte P&A Society Inc. accepts no responsibility for any accident or injury and shall not be made liable for any loss or damage to stall holders' property or person.

6. Food vendors must comply with all South Australian food safety laws and provide a Food Business Notification Number in accordance with council regulations.

7. Confirmation of site allocation and trade passes will be forwarded to the email address on the Trade Site Application Form prior to the show.

8. Vendors are only permitted to sell/display and/or exhibit the products/goods that are stated on their Trade Site Application Form and that are accepted and approved by the Naracoorte P&A Society Inc.

9. All trade sites are to be set up by 9.00am on Saturday October 14th and are to be dismantled no sooner than 4.00pm on this day.

10. Vehicles that have been included in trade site space must remain stationary between 9am and 4pm Saturday 14th October.

11. Stall holders must seek permission from the Naracoorte P&A Society before driving any objects into the ground, to ensure that there are no underground power cables or water pipes which could be damaged or cause anyone injury.

12. Any and all damages caused by stall holders, their staff or assistants will be repaired and paid for with full cost borne by the stall holder.

13. No stall holder will sell or supply any items from the nationally banned list of items for Agricultural Shows.

14. Trade sites selling alcoholic beverages must supply their own Responsible Service of Alcohol Certificate and Liquor License. These must be sent in with your application form for your site to be considered.

15. Failure to comply with these conditions may result in the application for a trade site being rejected, or the trade stand being shut down. No refunds will be given for non-compliance.

16. **OUTDOOR SITES:** If you wish to be placed in a specific area, please state this on your application form. Average outdoor sites are usually 6m x 6m, but we do not have any restriction on the size of your outdoor site. HOWEVER, can you please fill in the dimensions you require so we can accommodate you appropriately.
